

**PERTAINING TO AN APPLICATION FOR FUNDING UNDER THE MARYLAND
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR FUNDS AWARDED
THROUGH THE FEDERAL CARES ACT**

WHEREAS, the State of Maryland through the Department of Housing and Community Development has solicited applications from eligible jurisdictions to apply for funding under the Maryland Community Development Block Grant Program for funds awarded through the federal CARES Act;

WHEREAS, Calvert County, Maryland is eligible to apply for funds from the Maryland Community Development Block Grant program through the Maryland Department of Housing and Community Development;

WHEREAS, the County Commissioners of Calvert County, Maryland (the "County Commissioners") is a unit of general local government receiving or expecting to receive CDBG funds;

WHEREAS, after due notice, the County Commissioners have held the required public hearings on September 29, 2020 in order to hear public comments related to the formulation of Calvert County, Maryland's Block Grant Application;

WHEREAS, the County Commissioners understand and acknowledge that they would be responsible for completion of grant activities and any corrective actions including the repayment of funds if necessary; and

WHEREAS, upon consideration of all testimony, the County Commissioners have determined that application is in the best interest of the health, safety and welfare of the citizens of Calvert County, Maryland.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Calvert County, Maryland that authorization is hereby granted for the submittal of an application for the Community Development Block Grant funds in the amount of Six-Hundred and Forty-Eight Thousand Dollars (\$648,000) this 29 day of September 2020, for the following non-profit and community-based organization project(s) that prevent, prepare for, and respond to the coronavirus crisis:

- Rental Assistance for Low- and Moderate- Income Households

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that the President of the Board of County Commissioners is hereby authorized and empowered to execute any and all documents required for the submission of an application.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid.

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary.
