

**PERTAINING TO THE APPLICATION FOR A MARYLAND COMMUNITY DEVELOPMENT BLOCK GRANT CONTINUATION BY THE BOARD OF COUNTY COMMISSIONERS OF CALVERT COUNTY, MARYLAND, FOR FUNDING TO ASSIST IN THE ACQUISITION AND RENOVATION OF 85 MAIN ST., PRINCE FREDERICK, MARYLAND 20678**

**WHEREAS**, State of Maryland, through the Department of Housing and Community Development (“DHCD”), has solicited applications from eligible jurisdictions to apply for funding under the Maryland Community Development Block Grant Program;

**WHEREAS**, Calvert County is eligible to apply for funds from the Maryland Community Development Block Grant program through the Maryland Department of Housing and Community Development;

**WHEREAS**, the Board of County Commissioners of Calvert County (the “Board of County Commissioners”) deems it to be in the best interest of Calvert County to submit an application to the Department of Housing and Community Development (DHCD) for funding under the CDBG program to acquire and renovate 85 Main Street, Prince Frederick, MD 20678;

**WHEREAS**, a public hearing regarding the application was duly advertised and conducted on June 7, 2022, at which time the Board of County Commissioners received public comment; and

**WHEREAS**, the Board of County Commissioners understand and acknowledge that they would be responsible for completion of grant activities and any corrective actions including the repayment of funds if necessary;

**WHEREAS**, upon due consideration of the comments of the public and staff, the Board of County Commissioners finds it is in the best interest of the public health, safety, and welfare of the citizens of Calvert County, Maryland, to approve the application to DHCD for funding under the CDBG program to acquire and renovate 85 Main Street, Prince Frederick, MD 20678.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners approve and authorize the submittal of an application for Community Development Block Grant funds in the amount of Eight Hundred Thousand Dollars (\$800,000) to acquire and renovate 85 Main Street, Prince Frederick, MD 20678;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners that the President of the Board of County Commissioners of Calvert County, Maryland is authorized and empowered to execute any and all documents required for the submission of the application;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners that in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provisions, and that the remainder of this Resolution shall be enforceable and valid;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners that the foregoing recitals are adopted as if fully rewritten herein; and

**BE IT FURTHER RESOLVED** by the Board of County Commissioners that this Resolution shall be effective upon recordation without publication of a fair summary.
